

SECTION 1: BUILDING PERMIT FEES

Permits applied for in person

Permit processing fee for each permit issued or a combination of trades for the same location taken out at the same time: \$ 40.00

Contractor Change per trade \$ 40.00

Terms of Permit Issuance

Permits are valid for a period of **one year** from date of issuance. Applicants may apply for a 180 day extension of permits **prior to the date of expiration**. A \$30.00 per trade extension fee will be charged to extend the term of the permit for the requested 180 days. Permits that have expired after the one year timeframe, or after the requested 180 day extension, will be subject to the **full permit fee** required at the time of initial issuance based upon the fee schedule adopted at the time of renewal.

Permits for Attached Single-Family Residences (Condominiums)

Permits for Attached Single-Family Residences (condominiums) will be issued separately for each individual dwelling unit. This will not increase the total permit fee for the structure, but will assist in scheduling inspections for each individual unit.

A. Basis for computing fee.

The Building Official shall determine valuation for computing building permit fees as follows.

- 1) The Building Official may accept an estimate furnished by the applicant for a permit; or
- 2) May require a certificate of the cost of construction from a licensed architect or registered engineer; or
- 3) May require an affidavit from the owner or the owner's agent setting forth the estimated cost of the proposed work; or
- 4) May make such estimate as Building Official based on square footage per section B and C.

Fees are then computed per Valuation schedule below (sub-section D).

SECTION 3: PLUMBING PERMIT FEES

Permit processing fee for each permit issued \$ 40.00

A. Residential:

1) Each fixture opening \$ 15.00

Fixture openings are defined as: bath fixtures, kitchen sink, disposal, dishwasher, water heater (new or replacement), laundry tub, clothes washer box, floor drains, sewer hookup, water connection, water softener (new or replacement), sump pump, sewage ejectors, interior roof drains, storm sewer, and any appliance or fixtures not listed here that would be connected to a private or public plumbing system.

2) Backflow prevention (lawn sprinkler) \$ 25.00 each

3) Radon \$ 50.00

B. Commercial, Industrial and other:

1) Fee per fixture \$ 20.00

Fixture openings defined same as Residential

2) Backflow Prevention Device \$ 40.00

3) Fire suppression systems \$ 25.00

Per sprinklers head \$ 1.00 per head.

4) Sewer **or** water service \$ 40.00 each

Sewer **and** water service \$ 65.00

5) Radon \$ 50.00

C. Inspections: Four inspections are included with permit: sewer/water, underground rough-in, above ground rough-in, and final.

Any additional inspections/re-inspections \$ 50.00 per inspection.

SECTION 4: MECHANICAL PERMIT FEES

SECTION 5: OTHER FEES:

A. Testimonial/Court Fees:

Fee per hour

\$ 60.00 per person

Per hour includes actual court time, also time waiting for court call that prevents inspectors from proceeding with his regular inspection duties.

B. Plan Review:

A deposit of \$500.00 (includes a processing fee) is required at the time plans are submitted. This fee covers the first five hours of plan review. The balance of the fee must be paid before permits can be issued. These fees are based on the number of hours required to perform the Plan Review billed at a rate of \$ 100.00 per hour.

SECTION 6: ARCHITECTURAL LAW:

All commercial, industrial, institutional and residential buildings other than 1 & 2 family under 3 stories are subject to the Architectural Law of the State of Illinois and will require plans drawn and stamped by a licensed architect or engineer.
