ITEMS FOR CONSIDERATION:

- 1) The Committee discussed a Resolution authorizing a donation to Keep Northern Illinois Beautiful in support of the 2017 Annual Christmas Tree Recycling Program. Ald. Jacobson moved for approval; seconded by Ald. Pruitt. Motion carried: 4 ayes – 0 nays.
- 2) The Committee discussed an Ordinance amending Chapter 86, Article X of the Loves Park Code of Ordinances to clarify the timing requirements for the requesting of an administrative hearing following a vehicle impound. Ald. Jacobson moved for approval; seconded by Ald. Pruitt. Motion carried: 4 ayes – 0 nays.
- 3) The Committee discussed an Ordinance amending Chapter 54, Article VII, Division 3 of the Loves Park Code of Ordinances to prohibit the use, purchase and possession of alternative nicotine products and accessories by minors in the City of Loves Park. Ald. Jacobson moved for approval; seconded by Ald. Peterson. Motion carried: 4 ayes – 0 nays.
