Mr. Thompson indicated that the properties stated are located in the Oakcrest subdivision, in the Southwest quadrant of Harlem Road and McFarland Road. This area was developed in the mid/late 1960's to early 70's and is located in an unincorporated pocket area of Winnebago County that is completely surrounded by the City of Loves Park. Last summer, the Rock River Water Reclamation District constructed a sanitary sewer extension through this area to serve the residents. Due to the fact that the City of Loves Park participated in the funding of this extension, an agreement was put in place requiring residents that wanted to connect to the sewer extension to annex to the City of Loves Park.

He reported that each of these addresses have connected to the sewer extension and signed an annexation agreement with the City of Loves Park. All properties listed are contiguous to the Loves Park city limits and meet the Illinois State Statutes regarding annexation of property by a municipality. The properties are all single-family residences and will remain as such. Upon annexation, the properties will be zoned R1 (single-family residential), in accordance with the Loves Park Comprehensive Plan, and will be subject to the zoning restrictions set forth in the Loves Park Zoning Ordinance.

Mr. Thompson added that the annexation of these properties will help to reduce the number of unincorporated parcels in this pocket area. By eventually eliminating this pocket area through future annexations, the city is able to consolidate services such as police, fire, road maintenance, and plowing services. Currently, this area is served by Winnebago County Sherriff's Department, North Park Fire District and Harlem Township. Annexation of these properties will also result in a tax bill savings to the resident due to the fact they will no longer be paying taxes to these agencies for services that will be provided by the city. The annexation of these properties does not have any adverse effect, or burden on services provided by the city, as some of these services are already being conducted by the city through mutual jurisdictional agreements between the city and Harlem Township.
