- 1) The Committee considered a Resolution authorizing the Fire Chief to hire LM Sheet Metal Inc. to supply and install a new 1.5 Mitsubishi A/C unit at Fire Station #1 and also to supply and install two new Modine 150,000 BTU heaters at Fire Station #2. Ald. Jacobson moved for approval; seconded by Ald. Pruitt. Motion carried: 4 ayes 0 nays.
- 2) The Committee considered a Resolution authorizing a Master Equipment Lease Purchase Agreement for five 2017 Ford Interceptor Utilities and associated exhibits. Ald. Jacobson moved for approval; seconded by Ald. Peterson. Motion carried: 4 ayes 0 nays.
- 3) The Committee considered a Resolution authorizing the purchase of 8 bus benches from Tolar Manufacturing Company Inc. for a cost not to exceed \$11,000.00. Ald. Jacobson moved for approval; seconded by Ald. Peterson. Motion carried: 4 ayes 0 nays.
- 4) The Committee considered a Resolution authorizing the purchase of 8 planters from Wausau Tile for a cost not to exceed \$4,400.00. Ald. Jacobson moved for approval; seconded by Ald. Peterson. Motion carried: 4 ayes 0 nays.
- 5) The Committee considered a Resolution authorizing the City of Loves Park to enter into a contract with Nelson's Flowers and Greenhouses for bus bench beautification for a cost not to exceed \$10,500.00. Ald. Jacobson moved for approval; seconded by Ald. Peterson. Motion carried: 4 ayes 0 nays.
- 6) The Committee considered an Ordinance authorizing and providing for the issuance and sale of General Obligation Refunding Alternate Bonds (motor fuel tax alternate revenue source), Series 2017, of the City of Loves Park, Winnebago and Boone Counties, Illinois, for the purpose of refunding all or a portion of the outstanding aggregate principal amount of general obligation alternate bonds (motor fuel tax alternate revenue source), series 2007, of the City of Loves Park. Ald. Jacobson moved for approval; seconded by Ald. Pruitt. Motion carried: 4 ayes 0 nays.
