- 1) The Committee discussed a Resolution authorizing the Mayor to enter into an Intergovernmental Cooperation Agreement made by and between the City of Loves Park and the Harlem School District for the assignment of a School Resource Officer at the Harlem Middle School. Ald. Jacobson moved for approval; seconded by Ald. Pruitt. Motion approved: 4 ayes 0 nays.
- 2) The Committee discussed a Resolution authorizing the City Clerk to make Illinois Municipal League conference reservations. Ald. Jacobson moved for approval; seconded by Ald. Peterson. Motion approved: 4 ayes 0 nays.
- 3) A presentation was given by Jimsi Kuborn and Carrie Zethmayr from the Rockford Area Economic Development Council (RAEDC) for a funding request from the City of Loves Park in support of economic development efforts in the greater Loves Park and surrounding areas. The funding request was for a level of support of \$25,000 per year for the next five years. Mayor Lindberg stated the City Council will take the request under advisement.

Chairman Jury asked if the Committee had any questions regarding the list of bills. There were no questions regarding the bills. The Committee had no other questions or concerns. There was no public comment nor general discussion.
