- 6. NEW BUSINESS
 - A. 6333 North Second Street Special Use Permit for a fitness center/health club in the CR Zoning District. Appropriate notice has been given.

Timothy Lennon, 425 W. Water Street, Suite 275, Appleton, WI 54911 was sworn in as Petitioner. Mr. Lennon indicated that Planet Fitness would like to occupy the space at 6333 North Second Street. The club they currently have in Rockford is a 20,000 sq. ft. facility with an average of 7,000 members. The club is focused on the first time gym user

and will operate 24 hours a day; the facility will also draw traffic to neighboring businesses.

Chairman Wilhelmi asked if the fitness center would be selling any type of retail.

Mr. Lennon answered that retail sales is very limited.

Paul Meyer, 6409 First Street, Loves Park, IL was sworn in and asked what the impact would be to the adjacent residential neighborhood. He wanted to know why he was notified of the petition.

Mr. Stromberg explained to Mr. Meyer that it is a requirement of the city to notify all adjacent property owners within 250 feet of 6333 North Second Street.

Mrs. Novak moved to approve the Special Use Permit for a fitness center/health club in the CR Zoning District for the property commonly known as 6333 North Second Street, with the following conditions: 1. The Special Use Permit shall expire with the sale of the business or discontinuance of the business. 2. All new parking areas shall be striped according to the official site plan. Second by Mr. Kern. The findings of the facts have been met and discussed in accordance with the zoning recommendations provided.

B. 7917 Orion Street – A Variance from a required 10 ft. building setback to a requested 3 ft. building setback in the R1 Zoning District. Appropriate notice has been given.
