12. Continue City Council With 10 Alderpersons Alderman John Jacobson presented the following resolution of the City of Loves Park, Boone and Winnebago Counties, Illinois to continue a City Council consisting of ten Alderpersons elected two-each within five wards in the City. WHEREAS, the City of Loves Park ("City") operates pursuant to Article 3.1 of the Illinois Municipal Code (65ILCS 5/3.1 et seq); and WHEREAS, the City has previously elected to use a provision of Article 3.1 that gives the City an option for its council to be comprised of ten (10) alderpersons elected two (2) each from the City's five (5) wards; and WHEREAS, Article 3.1 requires the City to renew this resolution with one (1) year after receipt of every decennial census if it desires to keep its current council size; and WHEREAS, on August 12, 2021 the United States Census Bureau released the 2020 decennial census information containing the City's population; and WHEREAS, the City has determined it to be in its best interests to continue having its council size remain at tem (10) alderpersons elected two (2) each from the City's five (5) wards. NOW THEREFORE BE IT RESOLVED by the Mayor and the City Council of the City of Loves Park, County of Winnebago and County of Boone, Illinois, that by the adoption of this resolution, that the Mayor and the City Council hereby agree as follows:

- The above recitals are hereby incorporated into this Resolution as if fully stated herein.
- 2. The City of Loves Park shall continue to have a City Council comprised of ten (10) alderpersons pursuant to Article 3.1 of the Illinois Municipal Code (65 ILCS 5/3.1-20-10(b).
- 3. The City of Loves Park will continue to have (5) wards pursuant to Article 3.1 of the Illinois Municipal Code (65 ILCS 5/3.1-20-15) and shall elect two (2) alderpersons from each ward.
- 4. This resolution shall be in full force and effect immediately upon its passage and publication as required.
- 5. This resolution shall remain in effect until such time it is rescinded, or it is replaced by a substantially similar resolution after the next occurring decennial census results for the City are posted by the United States Census Bureau.

Alderman John Jacobson presented the following resolution authorizing the Mayor to execute a First Amendment to the Sales Tax Revenue Sharing Agreement between the City of Loves Park, Illinois and Spring Creek Development Company et al. **WHEREAS**, The City of Loves Park, Boone and Winnebago Counties, Illinois ("City"), is a duly constituted, organized and validly existing municipality within the meaning of Section 1 of Article VII of the 1970 Constitution of the State of Illinois, and is operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq., as amended; and **WHEREAS**, on December 12, 2018, pursuant to Section 8-11-20 of the Illinois Municipal Code, 65 ILCS 5/8-11-20, the corporate authorities entered into an economic incentive agreement ("Agreement") with Interstate Boulevard Property LLC, an Illinois limited liability company, SCL Business Park LLC, an Illinois limited liability company, and Spring Creek Development Company, an Illinois corporation (collectively referred to as "Developer") relating to the development or redevelopment of land within the corporate limits of the municipality

("Developer Property"); and **WHEREAS**, in order to further development of Developer Property, Developer requested the City to provide economic incentives to Skyland Corporation, an Illinois corporation that purchased a portion of the Developer Property ("Interstate Property"); and **WHEREAS**, Developer has agreed to waive its rights to the sales taxes generated on the Interstate Property pursuant to the Agreement so those sales taxes can be used to provide economic incentives to Skyland Corporation; and **WHEREAS**, the City and Developer desire to enter into a First Amendment to the Sales Tax Revenue Sharing Agreement with Developer to memorialize Developer's agreeing to waive its right to the sales taxes generated on the Interstate Property during the period the City is obligated to make economic incentive payments to Skyland Corporation. **NOW THEREFORE BE IT RESOLVED**, by the City Council of the City of Loves Park, Illinois, that by the adoption of this resolution, that the City hereby agrees:

- The above recitals are hereby incorporated into this Resolution as if fully stated herein

WHEREAS, The City of Loves Park, Boone and Winnebago Counties, Illinois ("City"), is a duly constituted, organized and validly existing municipality within the meaning of Section 1 of Article VII of the 1970 Constitution of the State of Illinois, and is operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seg., as amended; and WHEREAS, on May 13, 2019, pursuant to Section 8-11-20 of the Illinois Municipal Code, 65 ILCS 5/8-11-20, the corporate authorities entered into an economic incentive agreement ("Agreement") with Skyland Corporation, an Illinois corporation (Skyland") relating to the development or redevelopment of land within the corporate limits of the municipality; and WHEREAS, pursuant to Section C.6. of the Agreement, Skyland agreed to irrevocably assign to the City all of its rights to any deed restrictions or covenants existing upon certain properties identified in the Agreement so that the City may extinguish those restrictions; and WHEREAS, the City has drafted and desires to enter into an Assignment of Rights in Restrictive Covenants ("Assignment") to effectuate and memorialize the assignment required by Section C.6 of the Agreement. NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Loves Park, Illinois, that by the adoption of this resolution, that the City hereby agrees:

- The above recitals are hereby incorporated into this Resolution as if fully stated herein.
- 2. The City Council hereby approves the Mayor to sign the Assignment on behalf of the City in substantially the same form as attached hereto as Exhibit "A".

WHEREAS, on May 13, 2019, pursuant to Section 8-11-20 of the Illinois Municipal Code, 65 ILCS 5/8-11-20, the corporate authorities entered into an economic incentive agreement ("Agreement") with Skyland Corporation, an Illinois corporation ("Skyland") relating to the development or redevelopment of land within the corporate limits of the municipality; and WHEREAS, pursuant to Section C.3. of the Agreement, Skyland was permitted to reallocated \$200,000.00 of incentive derived from the SR Property to the Interstate Property, as those terms are identified in the Agreement; and WHEREAS, Skyland has notified the City of its desire to reallocate incentives consistent with the terms of the Agreement; and WHEREAS, the City has drafted and desires to enter into a First Amendment to the Economic Incentive Agreement to effectuate and memorialized the reallocation of incentives pursuant to terms of the Agreement. NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Loves Park, Illinois, that by the adoption of this resolution, that the City hereby agrees:

- 1. The above recitals are hereby incorporated into this Resolution as if fully stated herein.
- 2. Alderman John Jacobson presented the following resolution authorizing the Mayor to enter into a settlement agreement between the City of Loves Park. Illinois and TH Foods, Inc., an Illinois Corporation, for payment of unpaid water consumption fees. WHEREAS, the City of Loves Park, Boone and Winnebago Counties, Illinois ("City"), is a duly constituted, organized and validly existing municipality within the meaning of Section 1 of Article VII of the 1970 Constitution of the State of Illinois, and is operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq., as amended; and WHEREAS, pursuant to 65 ILCS 6/11-129-1 of the Illinois Municipal Code the City operates a waterworks system ("Water Department"); and WHEREAS, TH Foods, Inc., an Illinois corporation ("TH Foods") is a manufacturer located in the City connected to and receiving water from the Water Department; and WHEREAS, on or about January 2020 the Water Department recognized significant discrepancies in meter readings at TH Foods and determined that an under-calculation of water consumption had been occurring at TH Foods for several years; and WHEREAS, the City is limited by 65 ILCS 5/11-150-2(a)(1) to bill for unbilled service within twenty-four (24) months (Lookback Period"); and WHEREAS, the City performed a review of TH Foods invoicing and payments and an extensive mathematical analysis of historic meter readings, the result of which were presented to TH Foods; and WHEREAS, through negotiation with TH Foods, the parties agreed upon setting a Lookback Period of June 2018 through May 2020 for unbilled services and agreed on the mathematical analysis determining the amount of unpaid water fees due and owing to the City being set at eighty-one thousand sixty-six dollars (\$81,066.00) ("Settlement Amount"); and WHEREAS, the parties have drafted and approved the terms of an agreement ("Settlement Agreement") in substantially similar form as that attached as "Exhibit A" that will permit TH Foods to pay the Settlement amount in twelve (12) equal monthly installments by adding those

payments to their then-current monthly fees; and **WHEREAS**, the City has determined it to be in its best interest to authorize the Mayor to enter into the Settlement Agreement with TH Foods. **NOW THEREFORE BE IT RESOLVED**, by the City Council of the City of Loves Park, Illinois, that by the adoption of this resolution, that the City hereby agrees:

- The above recitals are hereby incorporated into this Resolution as if fully stated herein.
- 2. The city Council hereby approves of and authorizes the Mayor to enter into the Settlement Agreement in substantially the same form as attached hereto as Exhibit "A".
