A To Z Towing Alderman John Jacobson presented the following resolution authorizing the Mayor to execute a Service Agreement between the City of Loves Park, Illinois and A To Z Service Towing, Inc. WHEREAS, the City of Loves Park, Boone and Winnebago Counties, Agreement Illinois ("City"), is a duly constituted, organized and validly existing municipality within the meaning of Section 1 of Article VII of the 1970 Constitution of the State of Illinois, and is operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq., as amended; and WHEREAS, A to Z Towing, Inc., an Illinois corporation, having its principal place of business at 6905 Elm Ave, Loves Park, IL 61111 ("A to Z") provides towing and vehicle storage services; and WHEREAS, City desires to update the agreement with A to Z to allow for increased fees to reflect the added costs that have been incurred since the agreement first went into effect; and WHEREAS, the City has determined that the terms of the Service Agreement are acceptable and are in the best interest of the City and its citizens. NOW THEREFORE BE IT RESOLVED, by the City Council of the City of Loves Park, Illinois, that by the adoption of this resolution, that the City hereby agrees:
  - 1. The above recitals are hereby incorporated into this Resolution as if fully stated herein.
  - 2. The City Council hereby approves the Service Agreement and authorizes the Mayor or his designee to execute the Service Agreement, in substantially the same form as attached hereto as Exhibit "A".
  - 3. This Resolution will be in full force and effect from and after its passage, approval, and publication in pamphlet form in the manner provided by law.

## **RESOLUTION NO. 22-15**

15. Public Question Alderman Jacobson presented the following resolution providing for the submission of To Electors To a public guestion to the electors of the City of Loves Park, Illinois, at the General Primary Election to be held on June 28, 2022, as to whether the City should continue Continue to impose a Non-Home Rule Municipal Retailers' Occupation Tax and a Non-Home Municipal Retailers' & Rule Municipal Service Occupation Tax for expenditure on public infrastructure. WHEREAS, the City of Loves Park, Boone County and Winnebago County, Illinois (the Municipal Service "City") is an Illinois municipal corporation organized and operating under the Illinois Municipal Code, 65 ILCS 5/1-1-1 et seq.; and WHEREAS, the City is a non-home rule Occupation Taxes municipality; and

Public Question To Electors To Continue Municipal Retailers' & Municipal Service Occupation Taxes (Continued) WHEREAS, pursuant to 65 ILCS 5/8-11-1.1, the corporate authorities of a non-home rule municipality may, upon approval of the electors of the municipality, impose by resolution a Municipal Retailers' Occupation Tax and Municipal Service Occupation Tax; and WHEREAS, revenues from such Municipal Retailers' Occupation Tax and the Municipal Service Occupation Tax may be used for expenditure on public infrastructure: and WHEREAS, with strong support from the citizens of Loves Park, a referendum was passed on March 18, 2014, authorizing a Municipal Retailers' Occupation Tax and a Municipal Service Occupation Tax be imposed; and WHEREAS, the tax revenue has provided the funds for successful road and other infrastructure improvements around the City with significant contributions of non-residents who shop within the City; and WHEREAS, the current tax expires in 2024 and the City is requesting to continue the Municipal Retailers' Occupation Tax and a Municipal Service Occupation Tax for an additional ten-year period thereafter; and WHEREAS, the City intends to continue the use such revenue solely for expenditure on public infrastructure as provided for by statute; and WHEREAS, in the event the imposition of the Municipal Retailers' Occupation Tax and a Municipal Service Occupation Tax is approved by the voters, the City will only levy such taxes through June 30, 2034, after which date the levy will expire; and WHEREAS, the Mayor and the City Council hereby find and determine that it is advisable, necessary and in the best interest of the City that the proposition to impose a one percent (1%) Municipal Retailers' Occupation Tax and a Municipal Service Occupation Tax pursuant to 65 ILCS 5/8-11-1.3 and 65 ILCS 5/8-11-1.4, be submitted to the electors of the City at an election to be held and conducted in accordance with the general election laws set forth in the Illinois Election Code. NOW THEREFORE BE IT RESOLVED, by the corporate authorities of the City of Loves Park, Illinois, that by the adoption of this Resolution, whose recitals are incorporated herein, that the City hereby agrees:

- 1. <u>Recitals.</u> The foregoing recitals are hereby adopted as the findings of the corporate authorities of the City and are incorporated herein as if stated fully.
- Proposition to Adopt Sales Tax. It is hereby found to be necessary and in the best interest of the City that the proposition to continue the imposition of a percent (1%) Non-Home Rule Municipal Retailers' Occupation Tax and Service Occupation Tax, pursuant to 65 ILCS 5/8-11-1.3 and 65 ILCS 5/8-11-1.4, be submitted to the electors of the City in order to provide for expenditures on public infrastructure including but not limited to, repairs, maintenance, improvements, and reconstruction of roadways, drainage systems, pedestrian and bikeway facilities and water systems.
- 3. <u>Submission of Question.</u> A public question, in substantially the following form, shall be placed upon the ballot and submitted to the qualified electors of the City at the General Primary Election to be held on June 28, 2022 ("Primary Election"), to wit:

"Shall the corporate authorities of the City of Loves Park, Illinois be authorized to continue to levy a Municipal Retailers' Occupation Tax and a Municipal Service Occupation Tax, at a rate of one percent (1%), until June 30, 2034 to be used for expenditures on public infrastructure, including but not limited to repairs, maintenance, improvements and reconstruction of roadways, drainage systems, pedestrian and bikeway facilities and water systems?" YES or NO.

4. <u>Notice.</u> In addition to those notices required by to be given by the Boone County Clerk and the Winnebago County Clerk pursuant to the Illinois Election Code, the City Clerk shall give notice that the public question will be on the ballot at least ten (10) days before the date of the Primary Election by posting a notice at the Loves Park City Hall, the City's principal office. The City may also, but is not required to, post the notice electronically on its website. The notice shall be substantially in the following form:

**NOTICE IS HEREBY GIVEN** that at the General Primary Election to be held on Tuesday, the twenty-eight day of June, 2022, the following proposition will be submitted to the voters of the City of Loves Park, Boone County and Winnebago County, Illinois:

"Shall the corporate authorities of the City of Loves Park, Illinois be authorized to continue to levy a Municipal Retailers' Occupation Tax and a Municipal Service Occupation Tax, at a rate of one percent (1%), until June 30, 2034 to be used for expenditures on public infrastructure, including but not limited to repairs, maintenance, improvements and reconstruction of roadway, drainage systems, pedestrian and bikeway facilities and water systems?"

The polls at the election will be open at 6:00 a.m. and will continue to be open until 7:00 p.m. of that day.

- 5. <u>Election Procedures.</u> The Primary Election shall be conducted, in all respects, in accordance with the provisions of the Illinois Election Code and with all laws providing for notice, publication, ballots, polling places and other procedures relating to such election.
- 6. <u>Direction to City Clerk.</u> The City Clerk is hereby directed to certify a copy of this Resolution to the Clerk of Boone County and the Clerk of Winnebago County not less than sixty-eight (68) days prior to the date of the Primary Election, in order that the public question set forth herein may be submitted to the electors at said election. This Certification shall be in substantially the same form as Exhibit "A", attached hereto and made a part hereof.
- 7. <u>Conflict.</u> That all ordinances, orders or resolutions or parts thereof in conflict herewith be and the same hereby are repealed, and this Resolution shall be in full force and effect upon its adoption and that this Resolution in any event shall be deemed to be subject to modification and application to comply with the General Election Law.
