Community Development Block Grant Alderman John Jacobson presented the following resolution, **WHEREAS**, the City of Loves Park is applying to the State of Illinois for a Community Development Block Grant, and **WHEREAS**, it is necessary that an application be made and agreements entered into with the State of Illinois. **NOW, THEREFORE, BE IT RESOLVED** as follows:
 - 1. That the City of Loves Park apply for a grant under the terms and conditions of the State of Illinois and shall enter into and agree to the understandings and assurances contained in said application.
 - 2. That the Mayor and City Clerk on behalf of the City execute such documents and all other documents necessary for the carrying out of said applications.
 - 3. That the Mayor and City Clerk are authorized to provide such additional information as may be required to accomplish the obtaining of such grant.

12. Accept Revised Bid From MaxCor For Rehabilitation & Painting Of Water Tower No. 1.

Alderman John Jacobson presented the following resolution accepting the revised bid from MaxCor, Inc. for the rehabilitation and painting of Water Tower No. 1 and authorizing the Mayor to sign a contract on the bid terms. **WHEREAS**, the City passed a Resolution on March 21, 2022, rejecting all bids previously received for the rehabilitation and painting of Water Tower No. 1 and authorizing the Mayor to negotiate with one or more companies to obtain a revised bid; and **WHEREAS**, pursuant to negotiation, MaxCor, Inc. has submitted a bid for \$1,024,100.00 which is attached hereto as Exhibit A; and **WHEREAS**, the City, finding that MaxCor, Inc. is a responsible bidder, wishes to accept the proposed bid and enter into a contract on its terms. **NOW**, **THEREFORE**, **BE IT RESOLVED**, by the Mayor and the City Council of the City of Loves Park, County of Winnebago and County of Boone, Illinois, that by the adoption of this resolution, that the Mayor and the City Council hereby agree as follows:

- 1. The above recitals are hereby incorporated into this Resolution as if fully stated herein.
- 2. The City hereby accepts the bid of MaxCor, Inc. for the rehabilitation and painting of Water Tower No. 1 in the amount of \$1,024,100.00.
- 3. The Mayor is authorized to sign a contract with MaxCor, Inc. in keeping with the terms of the Bid.
- 4. Should any provision of this Resolution be declared invalid by a court of competent jurisdiction, the invalidity of such provision shall not affect any of the other provisions of this Resolution.
- 5. This Resolution shall be in full force and effect from and after its passage and approval.

Alderman John Jacobson presented the following resolution and moved for its adoption: **RESOLVED**, that by the adoption of this Resolution, that the City of Loves Park, Illinois, is authorized to enter into a Redevelopment Agreement with Rocket Group, LLC., ("Developer"), relating to property located at 5919 North Second Street, within the North Second Street Tax Increment Financing Redevelopment Project Area, as per the attached Redevelopment Agreement. 14. Loves Park Corporate Center Redevelopment Project Area Alderman John Jacobson presented the following resolution regarding the negotiation of a Redevelopment Agreement regarding the possible reimbursement of certain expenditures in connection with the Loves Park Corporate Center Redevelopment Project Area. WHEREAS, the Mayor and City Council (the "Corporate Authorities") of the City of Loves Park, Winnebago County, Illinois (the "City"), in an effort to revitalize the local economy and provide for the redevelopment and reuse of an underutilized and blighted area within the community, have established the Loves Park Corporate Center Redevelopment Project Area in accordance with the Illinois Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 et seq., as amended (the "TIF Act"), and have enacted Tax Increment Financing ("TIF") pursuant to the TIF Act within the Project are to pay eligible "redevelopment project costs" as defined in the Act for the benefit of the Project Area; and WHEREAS, in order to stimulate private investment in the Project Area, it is necessary for the City to Provide TIF assistance to private parties utilizing the powers and authority conferred by the TIF Act; NOW THEREFORE BE IT AND IT IS **HEREBY RESOLVED**, by the Mayor and City Council of the City of Loves Park, Winnebago County and Boone County, Illinois, that:

- 1. The statements set forth in the preambles to this Resolution are found to be true and correct and are incorporated by reference and made a part of this Resolution.
- 2. The Corporate Authorities have been approached by East Riverside Farms, Inc. and Subtle Brewing Company, LLC (Collectively, "Developer"), to provide economic support for a proposed development (the "Developer Project"), with such parties stating that their Developer Project would not be economically viable but for the receipt of TIF assistance.
- 3. The City believes it to be in the best interests of the City and in keeping with the Loves Park Corporate Center Redevelopment Project Plan to explore whether the granting of TIF assistance to the Developer Project is warranted.
- 4. The Corporate Authorities authorize the Mayor and his designees to proceed in good faith with negotiating and preparing a Redevelopment Agreement ("RDA"), between the City and Developer or any one of them, however this authorization does not obligate the City to enter into an RDA, and shall reflect that TIF assistance shall be limited to payment or reimbursement of eligible redevelopment project costs as defined by the TIF Act. To the extend assistance is provided, such assistance shall also be dependent upon receipt of sufficient TIF revenue from the property where Developer will construct a new building and shall not become a general obligation of the City.
- 5. Such RDA shall provide that zoning, planned unit development, subdivision, and site plan approvals must be approved separately by the Corporate Authorities where otherwise required by law.
- 6. While Developer may of their own volition, begin to undertake certain costs and expenditures in the hope of the same being reimbursed pursuant to an RDA, all negotiations and all agreements relating to the redevelopment of portions of the Project Area shall be and shall remain non-binding on the City unless and until they are formally approved by the Corporate Authorities in a written RDA. The City shall not be liable for the payment of any costs, expenditures, or reimbursement obligations unless and until the same are authorized by a duly approved and enacted RDA which if
