ORDINANCE NO. 2019 -

AN ORDINANCE APPOINTING THE CITY ATTORNEY AND REAFFIRMING THE SPECIAL PROSECUTOR

WHEREAS, pursuant to the Illinois Municipal Code, 65 ILCS 5/1 *et seq.*, and other statutory provisions, the City of Loves Park, an Illinois municipal corporation ("City") is authorized and empowered to adopt and enforce the provisions of this Ordinance; and

WHEREAS, Gino Galluzzo of Nicolosi Galluzzo LLP, along with the attorneys of Nicolosi Galluzzo LLP, is the City Attorney ("City Attorney") and Philip A. Nicolosi is the Special Prosecutor for the City ("Special Prosecutor"); and

WHEREAS, Attorney Gino Galluzzo will be leaving Nicolosi Galluzzo LLP as of the end of business day October 14, 2019 and joining Galluzzo Law Group LLC, a firm he has founded; and

WHEREAS, the City desires to continue to retain Gino Galluzzo as City Attorney and therefore desires to replace Nicolosi Galluzzo LLP with Galluzzo Law Group LLC as the firm authorized to act as City Attorney as of October 15, 2019; and

WHEREAS, the City will continue to retain Phil A. Nicolosi as the Special Prosecutor; and

WHEREAS, the City Council has determined that the actions set forth in this Ordinance are in the best interest of the City.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVES PARK, WINNEBAGO AND BOONE COUNTIES, ILLINOIS AS FOLLOWS:

- 1. That the foregoing recitals are incorporated by reference herein and made a part hereof.
- 2. As of the end of business day October 14, 2019, Nicolosi Galluzzo LLP will no longer be retained by the City.
- 3. Effective October 15, 2019, Gino Galluzzo of Galluzzo Law Group LLC will be the City Attorney and members of his office may perform duties of City Attorney as Gino Galluzzo directs.
- 4. The retainer and hourly rates for the City Attorney will remained unchanged.
- 5. Phil A. Nicolosi will remain the Special Prosecutor for the City and this ordinance will not alter any terms of the Special Prosecutor.
- 6. The provisions of this Ordinance shall become effective upon passage and publication as required by law.
- 7. The provisions and sections of this Ordinance shall be deemed severable, and the invalidity of any portion of this Ordinance shall not affect the validity of the remainder.
- 8. All orders, resolutions, or Ordinances in conflict herewith are hereby repealed to the extent they conflict with this Ordinance, and this Ordinance shall take effect immediately following its passage, approval, and publication, as required by law.
