Alderman Peterson of the Codes and Regulations Committee announced that a meeting will be held Monday, April 6, 2020, following city council.

8. Participation In Emergency Loan Fund

Alderman Jacobson presented the following resolution approving participation in an emergency loan fund supporting area businesses. WHEREAS, the current COVID-19 emergency and the resulting Order from the Governor for the closure of businesses throughout the State of Illinois, while necessary for health and safety, is creating economic hardship for businesses throughout Winnebago County including those in Loves Park and affecting our citizens who are employed at such businesses throughout the County; and WHEREAS, the Northern Illinois Community Development Corporation (NICDC) in partnership with local banks, the City of Rockford, the County of Winnebago, and First Midwest Group have established a multi-million dollar COVID-19 Emergency Loan Fund to be administered by NICDC and the Rockford Local Development Corporation (RLDC) to provide 90-day bridge loans for businesses located within Winnebago County while they are completing the process to secure Small Business Administration (SBA) loans authorized in recent Federal legislation; and WHEREAS, the City of Loves Park has been asked to partner with the foregoing entities to widen the resources available for such loans; and WHEREAS, the bridge loans are to be sized from \$5,000 to \$50,000 to provide temporary working capital for creditworthy businesses to carry on operations and to keep employees working. Loans will not be able to be used for rent or existing debt service. The loans will be structured to be paid in full when the business receives its Small Business Administration loan and will be secured by liens or mortgages on business assets as well as with personal guarantees by the owners; and WHEREAS, it is in the best interests of the City and its residents to support area business to promote rapid economic recovery from the current crisis and hereby support funding for vital City services; and WHEREAS, participation in the COVID-19 Emergency Loan Fund is possible through the use of existing money in the NOW THEREFORE BE IT Economic Development Revolving Loan Fund. RESOLVED by the Mayor and the City Council for the City of Loves Park, County of Winnebago and County of Boone, Illinois, that by the adoption of this resolution, that the Mayor and the City Council hereby agree as follows:

- 1. The above recitals are hereby incorporated into this Resolution as if fully stated herein.
- The City will enter into a zero-interest loan agreement with the NICDC whereby the City shall loan the sum of Two Hundred Twenty-Five Thousand Dollars (\$225,000) to the NICDC to add to the newly created fund providing short-term bridge loans to creditworthy small businesses in Winnebago County.
- 3. The Mayor shall work with the City Attorney to document the loan and its terms to protect the interests of the City and shall bring the documentation back to the City Council for approval prior to the City being obligated to fund the loan.
- 4. Once repaid, the funds shall be returned to the Economic Development Resolving Loan Fund.

WHEREAS, BIG has remained in good standing on its loan with the City making the payments as required in timely fashion; and

WHEREAS, BIG and Arachnid 360, LLC are requesting that the City of Loves Park again subordinate its security interests relating to the City's loan to B.I.G. Properties LLC so that BIG may obtain additional financing from Wintrust Commercial Banking (as St. Charles Bank & Trust Company, ISAOA/ATIMA).

EXECUTIVE SUMMARY

RE: Subordination Agreement - B.I.G. Properties, Inc.

On March 31, 2015, the City of Loves Park entered into 2 separate security agreements with B.I.G. Properties LLC and Arachnid 360, LLC to secure a \$500,000 loan made to B.I.G. Properties, LLC ("Borrower"). Borrower granted the City a mortgage interest in the Premises commonly known as 6212 and 6320/6330 Material Avenue, Loves Park, Illinois ("Premises"). The City's mortgage interest was junior to a primary security interest granted to BMO Harris Bank, N.A. and the Small Business Administration (collectively "Primary Mortgage Holders") to secure the total amount of \$1,334,500.00 ("Senior Obligations"). The City also received a first priority lien in the racking systems located at the Premises and was provided with personal guarantees from Shawn Beall and Anthony P. Beall in the \$500,000 loan.

The City was also provided with a Security Agreement by Arachnid 360, LLC which purports to grant to the City a first priority security interests in all the assets of Arachnid 360, LLC. However, since the inception of the loan, the City's interest in the collateral of Arachnid 360 LLC was always junior to the interest of their primary lender, BMO Harris which had predated the security agreement to the City.

On June 24, 2019, Borrower refinanced its BMO loan with Wintrust Commercial Banking (as St. Charles Bank & Trust Company, ISAOA/ATIMA) who has asked the City to sign a subordination agreement so that it's mortgage interest could be senior to that of the City in the same position as BMO. The Senior loans ahead of the City then totaled \$1,188,439.41, (\$871,774.77 for Wintrust and \$316,664.64), for the SBA. This was a reduction of \$146,060.59 from the initial amount which was senior to the City. At that time the Council approved entering into a subordination agreement putting Wintrust in first position with its lien.

Currently, an additional financing is being planned and the City is again being asked to reaffirm its subordinated status in relation to the new loan. The City's loan original loan to B.I.G. of \$500,000 has been paid down to \$172,284.36 and it is scheduled to be fully satisfied in May of 2022. Regular payments have been made and the loan has not been in default. The new Bank financing will result in an additional \$1,000,000 loan to Arachnid increasing the senior loans ahead of the City by that amount.

The City will continue to hold a first priority lien in the racking systems located at the Premises which the original RLF loan was used to purchase and will also continue to have the personal guarantees from both Shawn Beall and Anthony P. Beall to secure the City's RLF loan. The City will have a junior mortgage position in the real estate as referenced above and will have a junior position in the assets of Arachnid 360.

Last summer, a commercial evaluation report was made by First American Professional Real Estate Services for both the 6320-6330 Material Ave. and 6212 Material Ave. properties. The 6320-6330 Material Ave. property was evaluated at \$24.50 per square foot; approximately \$2,000,000 in total value. The 6212 Material Ave. property was evaluated at \$48.00 per square foot; approximately \$1,700,000 in total value. Note that these are not actual appraisals, so the values are only approximations based on value per square foot. These would tend to show that the value of the real estate alone at roughly \$3,700,000 would be sufficient to pay both the Bank and the City in the event of default and there are still the other assets of both companies available as additional security.

AMENDED AND RESTATED SUBORDINATION AGREEMENT

THIS AMENDED AND RESTATED SUBORDINATION AGREEMENT is dated this 24th day of June, 2019, by and between ST. CHARLES BANK & TRUST, N.A., a Wintrust Community Bank, f/k/a ST. CHARLES BANK & TRUST COMPANY, ISAOA/ATIMA hereinafter referred to as "St. Charles Bank," ARACHNID 360, LLC, an Illinois limited liability company, hereinafter referred to as "Arachnid," and the CITY OF LOVES PARK, hereinafter referred to as "City."

RECITALS

WHEREAS, Arachnid has entered into a lending relationship with St. Charles Bank pursuant to a Term Note 1 dated June 24, 2019 in the original principal amount of \$1,900,000.00, a second Term Note 2 dated June 24, 2019 in the original principal amount of \$490,000, and a Revolving Line of Credit of Note dated June 24, 2019 in the original principal amount of \$2,000,000.00;

WHEREAS, as a part of that lending relationship, Arachnid has executed a General Business and Security Agreement which grants to St. Charles Bank a security interest in all of the assets of Arachnid, hereinafter referred to as the "Collateral";

WHEREAS, St. Charles Bank has required a first security interest in the Collateral as a part of its lending requirements to make the loan to Arachnid;

WHEREAS, the City currently has a security interest in the assets of Arachnid pursuant to a UCC-1 Financing Statement which was filed with the Illinois Secretary of State on April 6, 2015 with a Filing No. 020193050, hereinafter referred to as the "City Financing Statement";

WHEREAS, St. Charles Bank in order to make the loan to Arachnid requires a first security interest in the Collateral and requires that this Subordination Agreement be executed;

WHEREAS, the City and St. Charles Bank executed a Subordination Agreement dated June 24, 2019 by and through which the City agreed to subordinate its security interest in the Collateral to that of St. Charles Bank;

WHEREAS, St. Charles Bank is extending a further loan to Arachnid in the form of a Revolving Line of Credit in the amount of \$1,000,000 which the parties wish to incorporate into the terms of the Subordination Agreement. (The Term Note 1 dated June 24, 2019 in the original principal amount of \$1,900,000.00, a second Term Note 2 dated June 24, 2019 in the original principal amount of \$490,000, a Revolving Line of Credit Note dated June 24, 2019 in the original principal amount of \$2,000,000, and the Revolving Line of Credit Note dated of even date herewith in the original principal amount of \$1,000,000 are hereinafter collectively referred to as the "Notes".

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledge, the parties agree as follows:

- 1. All of the aforementioned Recitals paragraphs set forth above are incorporated herein by reference as though fully set forth herein.
- 2. Arachnid has granted to St. Charles Bank a security interest in the Collateral as security for Notes and other obligations of Arachnid to St. Charles Bank, whether currently existing or existing in the future. St. Charles Bank has perfected its security interest in the Collateral pursuant to the filing

of a UCC-1 Financing Statement with the Illinois Secretary of State on June 26, 2019 as document number 024539709.

- 3. The City is the holder and filer of the City Financing Statement.
- 4. The City subordinates any and all security interests that it may have in the Collateral as evidenced by the City Financing Statement or any other UCC-1 Financing Statement or Security Agreement that it may possess to the security interest of St. Charles Bank.
- 5. The City agrees that the subordination of its security interest with respect to the Collateral to the security interest of St. Charles Bank in the Collateral shall have the same force and effect as though the security interest of St. Charles Bank (as evidenced by its UCC-1 Financing Statement) have been executed, delivered and recorded with the Illinois Secretary of State prior to the execution, delivery and recording of any UCC-1 Financing Statement by the City.
- 6. The parties agree that St. Charles Bank shall have a first security interest in the Collateral.
- 7. The City further agrees and consents that in any proceedings that may be instituted by St. Charles Bank, its successors or assigns, with respect to the Collateral, including collection, foreclosure and/or replevin proceedings, that St. Charles Bank shall have a first security interest in the Collateral, including all proceeds generated from the liquidation thereof and that said proceeds shall be applied first to the indebtedness of Arachnid to St. Charles Bank evidenced by the Notes or any other notes, loan documents, or other obligations of Arachnid to St. Charles Bank, whether now existing or existing in the future, and any remainder shall thereafter be applied to the indebtedness of Arachnid to the City. The City further agrees that it shall receive no proceeds from the liquidation of the Collateral until St. Charles Bank has been paid in full for all amounts advanced to Arachnid whether under the Notes or any other loan documents, whether now existing or existing in the future.
- 8. The City further states that in the event of any bankruptcy filed by Arachnid, whether voluntary or involuntary, the security interest of St. Charles Bank shall be first and superior as to the Collateral and that St. Charles Bank shall be paid first with respect to the proceeds of sale of any of the Collateral.
- 9. The parties agree that in the event of any bankruptcy action, collection litigation, or other court proceeding, that St. Charles Bank shall have the absolute right to rely on this Amended and Restated Subordination Agreement as evidence of its first security position with respect to the Collateral. The City and Arachnid hereby waive any and all right to challenge the first security position of St. Charles Bank in the Collateral.
- 10. The City and Arachnid acknowledge and agree that but for this agreement signed by all parties, St. Charles Bank would not have agreed to have made the loan to Arachnid evidenced by the Notes. The City and Arachnid further agree that the loan evidenced by the Notes provides a benefit and ample consideration to each of them.
- 11. This Amended and Restated Subordination Agreement shall be construed pursuant to the laws of the State of Illinois and shall be binding upon the parties, their successors, heirs and assigns.

12. This Amended and Restated Subordination Agreement may be executed in any number of counterparts, all of which shall be taken to be one and the same instrument, for the same effect as if all parties hereto had signed the same signature page. Receipt of an executed signature page to this Subordination Agreement by facsimile or other electronic transmission shall constitute effective delivery thereof.

EMPLOYEE BENEFIT PLAN Amendment

- 3. Telemedicine visits will be covered as outlined in the Summary of Benefits.
- 4. Health coverage will be continued for employees who are not able to work and need to take a leave of absence due to COVID-19 challenges, including health concerns or school and daycare closures.
- 5. The definition of "Actively-at-Work" is changed to include employees who are working at home during the COVID-19 pandemic and employees who were Actively-at-Work on the day prior to closure of the business, if applicable.
- 6. Any exclusion related to a State of Emergency is deleted.

ORDINANCE NO. 4331-20

AN ORDINACE GRANTING SPECIAL TEMPORARARY POWERS AND AUTHORITY TO THE MAYOR OF CITY OF LOVES PARK, ILLINOIS IN RESPONSE TO A DECLARATION OF A LOCAL STATE OF EMERGENCY

WHEREAS, on March 10, 2020, the Governor of Illinois made a formal disaster declaration as a result of the spread of the COVID-19 virus; and

WHEREAS, on March 11, 2020, the World Health Organization declared the outbreak of COVID-10 to be a worldwide pandemic; and

WHEREAS, on March 13, 2020, the Governor of Illinois ordered the closing of all public and private schools as a part of the effort to mitigate the spread of the COVID-19 virus; and

WHEREAS, on March 15, 2020, the Governor order the closing of all bars and dine-in restaurants as a further effort to mitigate the spread of the COVID-19 virus; and

WHEREAS, the State Emergency Management Agency has declared a public Health emergency due to the impact of the COVID-19 virus; and

WHEREAS, the COVID-19 virus represents a threat to public safety and welfare; and

WHEREAS, on March 16, 2020, Pursuant to 65 ILCS 5-11-1-6, the Mayor of the City of Loves Park has made a Declaration of a Local State of Emergency; and

WHEREAS, 65 ILCS 5-11-1-6 provides that a municipality may make a declaration of a state of emergency and states that "the corporate authorities of each municipality may by ordinance grant to the mayor the extraordinary power and authority to exercise, by executive order, during a state of emergency, such of the powers of the corporate authorities as may be reasonably necessary to respond to the emergency;" and

WHEREAS, to protect the life, health and safety of the citizens of Loves Park, it is prudent, reasonable and necessary to take extraordinary precautions and the City desires to provide for the

exercise of extraordinary powers by executive order of the Mayor during the state of emergency; and

WHEREAS, it is deemed reasonable, necessary and prudent by the City Council to provide additional authority to the Mayor to be able to act swiftly to respond to the situations which may arise from this emergency.

NOW THEREFORE, IT IS HEREBY DECLARED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF LOVES PARK, ILLINOIS THAT A STATE OF EMERGENCY EXISTS AND IT IS ORDAINED THAT DURING THE PEIOD OF EMERGENCY, THE MAYOR WILL HAVE ADDITIONAL POWERS AND AUTHORITY AS GRANTED HEREIN.

- 1. Pursuant to this Declaration, the Mayor and, at his direction, all City Department heads, are to coordinate with all County, State and National agencies to provide for a unified response to the COVID-19 virus.
- 2. The Mayor is granted the authority to direct the resources of the City and to take all actions reasonably necessary to respond to the emergency.
- 3. The Mayor may approve previously appropriated expenditures and the payment of bills received in the ordinary course of business of the City for the purpose of continuing the operations of the City. As soon as practicable thereafter, the Mayor shall submit the City Council a detail of the expense.
- 4. In addition thereto, and in accordance with Section 2-388 of the Loves Park Code of Ordinances, the Mayor or his designee is authorized on behalf of the City to procure such services, supplies, equipment, or materials as may be necessary for such purposes, in view of exigency, without regard to the statutory procedures or formalities normally prescribed by City Code or other law pertaining to city contracts, purchases or obligations. As soon as practicable thereafter, the mayor shall submit the City Council a detail of the expense and the reason that a determination of extraordinary circumstances was made.
- 5. Pursuant to Executive Order of the Governor suspending the Open Meetings Act, any regular or special meeting of the City Council may be conducted at the call of the Mayor

or two Council members via electronic means including audio or video conference. Such meetings may be held, providing such notice to the public and media as is reasonable under the circumstances, and if possible, providing access to the public and including a means for public participation. All such meetings shall be considered "emergency Meetings" under the law. During this period of emergency, Council Rules are hereby modified to require an affirmative vote of a majority of a quorum present, electronically or physically, at the meeting for the passage of any Council bill or to provide policy direction.

- 6. The Mayor may cancel meetings of any board or commission to which the Mayor appoints members. Any such cancellation shall automatically extend such deadlines for required actions by such board or commission as is specified in the cancellation notice. Committees of the City Council are governed by the Chair of each such Committee.
- 7. The Mayor may suspend licenses or permits for special events or any other licenses or permits issued by the City which in the judgment of the Mayor could impact the public health or well-being of residents or visitors to the community.
- 8. The Mayor is authorized to adjust any personnel policies related to leave time, other benefits or terms and conditions of employment as are reasonably related to providing sufficient staffing during the term of the emergency.
- 9. The Mayor is hereby authorized to enter into such temporary agreements, including memoranda of understanding with the City's bargaining units in order to promote the provision of City services and the health and safety of the public and employees during the emergency.
- 10. The Mayor is hereby authorized to close City facilities as is reasonably required to protect the health of the public and employees of the City.
- 11. At the direction of the Mayor, the City Attorney is hereby authorized to extend any timeframe for payment or filing related to City ordinance violations in recognition of the emergency.
- 12. The Mayor, upon the recommendation of the City Treasurer, is hereby authorized to reasonably extend deadlines for payment related to any amounts due and owing to the City.

- 13. The City of Loves Park may continue to spend funds at the same rate as in the 2019-2020 Appropriation Ordinance until the 2020-2021 Appropriation Ordinance is approved and the City Treasurer is hereby authorized to make appropriation transfers within funds as provided by law for the payment of sums due from the City during the term of this Ordinance.
- 14. This Ordinance and the powers afforded the Mayor herein shall be effective for a period of thirty (30) days from the date enacted and shall continue for thirty (30) day periods thereafter unless repealed or amended by the City Council which may repeal this Ordinance at any time.
- 15. This Ordinance and the associated powers designated herein shall become effective immediately upon passage by the Corporate Authorities of the City of Loves Park.
- 16. If any provision of this Ordinance or the application thereof to any person or circumstance is ruled unconstitutional or otherwise invalid, such invalidity shall not affect other provisions or applications of this Declaration and Ordinance that can be given effect without the invalid application or provision and each invalid provision or invalid application of this Declaration is severable.

WHEREAS, on March 10, 2020, the Governor of the State of Illinois made a formal disaster declaration as a result of the spread of the COVID-19 virus; and

WHEREAS, on March 11, 2020, the World Health Organization declared the outbreak of COVID-19 to be a worldwide pandemic; and

WHEREAS, the Illinois State Emergency Management Agency has declared a public Health Emergency due to the impact of the COVID-19 virus; and

WHEREAS, the COVID-19 virus represents a threat to public safety and welfare; and WHEREAS, Pursuant to the authority vested in the office of the Mayor by the Illinois Municipal Code, Section 5/11-1-6 and the Illinois Emergency Management Agency Act Section 3305/11, the Mayor of a Municipality has the authority to declare a Local State of Emergency.
