Dear Mr. McDonald:

Loves Park has an existing aging serial radio system and multiple PLCs (Programmable Logic Controllers) from different manufacturers that are active mature and approaching end-of-life support. Active mature is a manufacturer-identified stage of hardware, which is currently available; however, due to its age, will soon be unsupported and no longer manufactured in the near future. If there becomes a need for replacement, not only will the support no longer be available but the pricing to replace the hardware can be substantially more expensive compared to updated newer technology. Furthermore, once the PLC reaches end-of-life, replacement hardware can typically only be found through unauthorized resellers or places like EBay that do not carry support or warranty.

Concentric Integration (Concentric) recommends the replacement of the existing serial radio system with a new secure cellular system that provides greater bandwidth. The cellular network will be secure as the cellular radios will be on a private Verizon network segment. This means that the City's SCADA communications over the cellular will be segregated from the public internet and therefore much less exposed to the potential of malicious attack. The increased bandwidth provided by the cellular radios will provide Loves Park with flexibility moving into the future to adopt technologies and operations changes that require greater bandwidth (for example, short-burst live streaming of video or reduced SCADA poll times). Additionally, Concentric anticipates that the City will have reduced ongoing maintenance costs associated with the antennas of the current radio infrastructure. Cellular antennas have a much smaller footprint and require very little maintenance to keep them functioning well.

In addition to the radio replacement, Concentric will replace, migrate, and (where necessary) reprogram the City's active mature PLCs throughout the network. The new PLCs will be sourced from a single manufacturer (Allen-Bradley), which should make ongoing support of the SCADA network less complex. Consistency of PLC manufacturer across all locations will ease the process of support work should the need arise, resulting in reduced support time and costs for the City.

WHEREAS, the City has negotiated with Paramedic Services of Illinois, Inc. to enter into an amendment the existing contract to increase the number of trained personnel provided to the City and to alter the administrative structure so as to reduce costs to the City overall from that originally budgeted; and

WHEREAS, the City, on May 18, 2020 passed a Resolution allowing for an Amendment to the contract with Paramedic Services of Illinois; and

WHEREAS, certain costs associated with the additional personnel were not accounted for in the Amendment, but were already budgeted for in the City's budget; and

WHEREAS, further amending the contract to include reimbursement to Paramedic Services of Illinois, Inc. rather than direct payment of certain sums by the City will not change the City's costs relating to fire and EMS.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and the City Council of the City of Loves Park, County of Winnebago and County of Boone, Illinois, that by the adoption of this resolution, that the Mayor and the City Council hereby agree as follows:

RESTATED AMENDMENT TO EMERGENCY SERVICES STAFFING AGREEMENT

THIS RESTATED AMENDMENT ("Restated Amendment"), is made by and between the City of Loves Park, Illinois, an Illinois Municipal Corporation ("City") and Paramedic Services of Illinois, Inc., an Illinois Corporation ("PSI"), which are the parties to an Emergency Staffing Services Agreement ("Agreement"), dated November 1, 2018 and modified from time to time thereafter.

WHEREAS, the City has determined that it is in the best interests of the Loves Park Fire Department to alter and amend its staffing and command structure which will result in greater efficiency and in a savings from original budget estimates for the City; and

WHEREAS, PSI is willing to accommodate the changes that City is proposing to make through the hiring of additional personnel and by altering the scope of duties of certain existing personnel; and

WHEREAS, the City and PSI have agreed upon the compensation to be paid by the City to PSI as a result of these changes; and

WHEREAS, the City and PSI have agreed that the original iteration of this Amendment passed by the City Council on May 18, 2020 failed to fully express the intent of the Parties and thus requires this restatement.

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein as well as the above recitals which are incorporated into this Restated Amendment, it is understood and agreed by and between the City and PSI as follows:

- 1. The above recitals are incorporated into this Restated Amendment as though fully restated herein.
- 2. The Amendment passed by the City Council on May 18, 2020 which is restated herein shall be considered null and void and shall be replaced, in its entirety by this Restated Amendment.
- 3. The gross compensation paid to PSI pursuant to Article 4 of the Agreement shall be increased to One Million Four Hundred Eighty-Eight Thousand Dollars (\$1,488,000) for fiscal year 2021 commencing on May 1, 2020.

- 4. The City shall further compensate PSI in a prorated amount not to exceed Two Hundred Forty Thousand Dollars (\$240,000) for fiscal year 2021, for as-needed, on-call personnel as set forth below with such funds to be referenced as the "On-Call Budget".
- 5. PSI shall provide staffing of both full and part-time personnel to fulfill firefighting and EMS functions of the Loves Park Fire Department.
 - a. PSI will provide eighteen (18) full-time persons to cover all shifts on a 24/7/365 basis with such persons properly certified for the positions each fills in accordance with directives of the Loves Park Fire Chief and the State of Illinois.
 - b. Commencing on July 5, 2020, PSI will also compensate and provide additional personnel who will function on an as-needed, on call, basis to augment and assist the full-time personnel.
 - PSI will invoice the City on a monthly basis in a form acceptable to the City
 Treasurer documenting the hours for additional on-call personnel who shall
 be paid from the On-Call Budget.
 - ii. In fiscal year 2022, the On-Call Budget shall be increased to Two Hundred Eighty-Eight Thousand Dollars representing a full year budget rather than the prorated amount set forth above.
 - iii. PSI will separately invoice the City for all associated hiring costs related to the on-call personnel, which includes without limitation, physicals, uniforms, and education and training. Invoices associated with physicals, uniforms, education and training for on-call personnel as stated herein shall be paid from an "Expense Budget." The Expense Budget for each fiscal year shall not exceed Eighteen Thousand Dollars (\$18,000).
- 6. No additional increase in compensation to PSI will be made in fiscal year 2021.
- 7. The two and one-half percent increases (2.5%) called for in future years pursuant to Schedule A of the Agreement shall go into effect in future years on May 1st with the start of the City's new fiscal year.
- 8. In all other respects, the Agreement shall remain in full force and effect.

AN ORDINANCE AMENDING CHAPTER 102, ARTICLE I, IN GENERAL, SECTION 102-9, DEFINITIONS OF THE CODE OF ORDINANCES OF THE CITY OF LOVES PARK

WHEREAS, the City of Loves Park is authorized and empowered by the Statute to adopt and enforce the provisions of this ordinance.

Text Amendment of the Loves Park Zoning Ordinance as follows:

Add. Chapter 102, Article I, In General, Section 102-9, Definitions, as follows:

Adult-use Cannabis Craft Grower means a facility operated by an organization or business that is licensed by the Illinois Department of Agriculture to cultivate, dry, cure and package cannabis and perform other necessary activities to make cannabis available for sale at a dispensing organization or use at a processing organization, per the Cannabis Regulation and Tax Act, (P.A. 101-0027), as it may be amended from time to time, and regulations promulgated thereunder.

Adult-use Cannabis Cultivation Center means a facility operated by an organization or business that is licensed by the Illinois Department of Agriculture to cultivate, process, transport and perform necessary activities to provide cannabis and cannabis-infused products to licensed cannabis business establishments, per the Cannabis Regulation and Tax Act, (P.A. 101-0027), as it may be amended from time to time, and regulations promulgated thereunder.

All other provisions of Chapter 102 - Zoning, Article III, Division 4 – Industrial, shall remain in effect as previously published.

The recommendation of the Zoning Board of Appeals on the question of granting this Text Amendment is hereby accepted, adopted and made a part of this Ordinance. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.

AN ORDINANCE ESTABLISHING NO PARKING ON THE BOTH SIDES OF CARLSON PASS BETWEEN EAST RIVERSIDE BOULEVARD AND SEBRING WAY IN THE CITY OF LOVES PARK, ILLINOIS

WHEREAS, Carlson Pass is a Public roadway within the limits of the City of Loves Park, Illinois;

NOW THEREFORE, IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVES PARK, ILLINOIS:

SECTION 1: That a No Parking zone be established on Carlson Pass in the City, Illinois, as follows:

- (a) That no parking shall be established on the both sides of Carson Pass between East Riverside Boulevard and Sebring Way.
- (b) That the No Parking area identified in (a) above has been determined to be necessary for the public safety and well-being of the residents and motorists of the City of Loves Park, Illinois.
- **SECTION 2:** That the appropriate No Parking signs shall be erected and curbing, if applicable, painted yellow to reflect the Ordinance.
- **SECTION 3:** This Ordinance is to become effective upon its passage, approval and publication in pamphlet form or in any other form as provided for by law.
- **SECTION 4:** That the Code of Ordinance of the City of Loves Park, Illinois shall be amended to include the provisions of this Ordinance.
- **SECTION 5:** This Ordinance repeals and amends the terms of any and all previous and/or existing Ordinance in conflict with the provisions contained herein.
- **SECTION 6:** That the City Clerk is hereby directed to publish this Ordinance in pamphlet form or in any other form as provided for by law.
