Alderman Schlensker of the Public Works Committee presented the Water Department list of bills dated February 1, 2021, in the amount of \$88,795.89, for consideration at next week's city council meeting.

12. Opposing House Bill 3653 Criminal Justice Reform Alderman Peterson presented the following resolution opposing House Bill 3653 in its current form and moved for its adoption. WHEREAS, the Illinois Legislature has recently passed Senate Floor Amendment No. 2 to House Bill 3653 which would enact sweeping reforms to the criminal justice system of our State if it becomes law; and WHEREAS, this Bill, consisting of over 700 pages, was passed in a matter of days with limited debate despite representing wide-ranging, substantive change; and WHEREAS, the City agrees that thoughtful and well-reasoned reform of the criminal justice system is both beneficial and necessary, but believes that the process used to bring about the changes represented in House Bill 3653 as amended, were not subject to sufficient study and consideration; and WHEREAS, well-intentioned items such as the elimination of cash bail except in cases where harm to specific individuals can be identified does not allow judges to evaluate the threat to the public as a whole in releasing violent offenders; and WHEREAS, the provision allowing the use of anonymous complaints against officers does not promote transparency or justice, but rather allows for social media style attacks promoting personal agendas without supporting evidence and without allowing the accused the ability to defend against the allegation; and WHEREAS, the bill is rife with unfunded mandates that will place additional strain on local police budgets; and WHEREAS, the City supports the Legislature undertaking a thoughtful and measured process for reform that involves all stakeholders and results in positive changes to our criminal justice system to right inequities that exist there in while protecting the community as a whole and not villainizing our police officers performing their duties with honor. NOW, THEREFORE, BE IT RESOLVED, by the Mayor and the City Council of the City of Loves Park, County of Winnebago and County of Boone, Illinois, that by the adoption of this Resolution, that the Mayor and the City Council hereby agree as follows:

- The above recitals are hereby incorporated into this Resolution as if fully stated herein.
- 2. The City commends the professionalism of the Loves Park Police Department and its officers in their work to both protect the City and for acting in a responsible manner in interacting with our citizens.
- 3. The City calls upon the Governor to veto House Bill 3653 as amended by Senate Floor Amendment Number 2 and calls upon the Legislature to take-up a process for thoughtful and studied reform of our criminal justice system allowing for meaningful input from all stakeholders.
- 4. In the alternative, the City calls upon the Legislature to immediately takeup modifying legislation to clarify, amend, and improve the provisions of House Bill 3653 as amended in order to address the foreseeable harm to the community associated with some of its provisions.
- 5. This Resolution shall be in full force and effect from and after its passage and approval.
