WHEREAS, the house located at 825 Marie Avenue ("Property") in the Village of Machesney Park (the "Village") is owned by Zion Development Corporation ("Zion") and will be used by the United Way for administering activities including, but not limited to neighborhood programs, and other activities all for the benefit of the neighborhood and the communities of the Village and the City of Loves Park (the "City"), as a whole. which the Village and the City each find to be beneficial to their respective community and which each wish to support through the provisions of this Agreement; and

WHEREAS, at the request of Zion and in furtherance of the beneficial programming provided to the Village and to the City at the Property, the expenses for utilities at the Property will be shared equally by the City and the Village. Additionally, Zion has requested that the Village undertake snow removal and salt application as needed for the driveway and sidewalks located at the Property, and that the City take responsibility to mow the grass as needed;

WHEREAS, the City desires to enter into an Intergovernmental Agreement ("Agreement") with the Village and with Zion, with regard to the general maintenance and expenses of the Property; and

WHEREAS, ZION, the Village and the City have reached an accord as to the terms and conditions of the shared responsibilities regarding maintenance and expenses for the Property; and

WHEREAS, Zion, the Village and the City have memorialized such terms and conditions in the Agreement, attached hereto as <u>Exhibit A</u> and incorporated herein; and

WHEREAS, the City has determined it is in the best interest of the City and its citizens to enter into the Agreement and to support the programs offered on the Property which benefit the citizens of both the City and the Village.

WHEREAS, the City now desires to approve said Agreement and authorize the Mayor to execute the Agreement and the City Clerk to attest the same.

NOW THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Loves Park, Winnebago and Boone Counties, Illinois, that:

- 1. The foregoing recitals are incorporated herein and made a part hereof.
- 2. By the Adoption of this Resolution, the City Council approves the City of Loves Park entering into the attached Agreement, or one in substantially similar form, and authorizes the Mayor to execute the same.
- 3. This Resolution will be in full force and effect from and after its passage, approval, and publication in pamphlet form in the manner provided by law.

INTERGOVERNMENTAL AGREEMENT BETWEEN THE VILLAGE OF MACHESNEY PARK AND THE CITY OF LOVES PARK FOR THE SNOW REMOVAL AND LAWN MAINTENANCE OF 825 MARIE AVENUE A/K/A STRONG HOUSE OWNED BY ZION DEVELOPMENT CORPORATION AS WELL AS THE PAYMENT OF UTILITIES ASSOCIATED WITH THE USE OF SUCH PROPERTY

THIS AGREEMENT ("Agreement") is entered into this _____ day of ______, 2021, by and between ZION DEVELOPMENT CORPORATION, an Illinois not-for-profit corporation ("ZION"), the VILLAGE OF MACHESNEY PARK, an Illinois municipal corporation ("Village"), and CITY OF LOVES PARK, an Illinois municipal corporation ("City"). The VILLAGE and the CITY are sometimes collectively referred to as the "PARTIES."

RECITALS

WHEREAS, the Village and the City are public agencies within the meaning of the Illinois Intergovernmental Cooperation Act, 5 ILCS § 220/1, *et seq.*, and are authorized by Article VII, Section 10 of the Constitution of the State of Illinois to cooperate for public purposes; and

WHEREAS, Article VII, Section 10, of the Illinois Constitution of 1970 and the Intergovernmental Cooperation Act, 5 ILCS § 220/1, *et seq.*, authorizes units of local government to contract or otherwise associate among themselves to obtain or share services, to exercise, combine or transfer any power or function, in any manner not prohibited by law, to use their credit, revenues and other reserves to pay costs and to service debt related to intergovernmental activities; and

WHEREAS, the Village and the City additionally are "units of local government," as defined in Article VII, Section 1, of the Illinois Constitution of 1970, and, therefore, pursuant to Section 10 of Article VII, have the power to contract among themselves to obtain or share services and to exercise, combine or transfer any power or function in any manner not prohibited by law or ordinance; and

WHEREAS, the house located at 825 Marie Avenue ("Property") in the Village is owned by Zion and will be used by the United Way for administering activities including, but not limited to neighborhood programs, and other activities all for the benefit of the neighborhood and the communities of Village and City as a whole. which the Village and the City each find to be beneficial to their respective community and which each wish to support through the provisions of this Agreement; and

WHEREAS, at the request of Zion and in furtherance of the beneficial programming provided to the Village and to the City at the Property, the expenses for utilities at the Property, including but not limited to the expenses identified on the attached Exhibit A, will be shared equally by the City and the Village. Additionally, Zion has

requested that the Village undertake snow removal and salt application as needed for the driveway and sidewalk located at the Property, and the City take responsibility to mow the grass as needed;

NOW, THEREFORE, in consideration of the promises and covenants herein contained, the PARTIES agree that:

1. <u>Recitals</u>. The above recitals are hereby incorporated into this Agreement as though fully set forth herein.

2. <u>Utilities</u>. The Village will pay all utilities, including but not limited to those identified on the attached Exhibit A, and will annually provide the City with an accounting of all sums paid for the utilities and the City agrees to reimburse the Village for 50% of the annual expense. Said payment is to be made within thirty (30) days of receipt by the City of the accounting for said expenses. During the course of each year, should the utility expenses exceed \$______, Village will notify the City so that it can anticipate the expense and so that the Parties may discuss how to reduce expenses.

3. <u>Snow Removal and Mowing</u>. Unless agreed otherwise by the Village and the City, it will be the Village's responsibility to provide snow removal and salting of the driveway as needed, and it will be the City's responsibility to mow the yard as needed all at no cost to Zion.

4. <u>Termination</u>. This Agreement may be terminated by any of the Parties on sixty (60) days written notice and/or by mutual agreement of the Parties.

5. <u>Miscellaneous</u>.

- a. <u>Amendment</u>. This Agreement may be amended or modified only by written instrument signed by Zion, the Village and the City, with any appropriate or acquired corporate action or authorization.
- b. <u>Construction</u>. This Agreement shall be construed according to the laws of the State of Illinois and any litigation arising out of this Agreement shall be brought in the Seventeenth (17th) Judicial Circuit, Winnebago County, Illinois. The Parties agree that the successful party in any litigation to enforce the terms and provisions of this Agreement shall be entitled to its reasonable costs and attorney fees to enforce the terms and provisions of the Agreement.
- c. <u>Severability</u>. It is agreed between Zion, the Village and City that the provisions of this Agreement are severable. If any provision, paragraph, section, subdivision, clause, phrase, or word of this Agreement is for any reason held to be contrary to law, or contrary to any rule or regulation having the force and effect of law, such decision shall not affect the remaining portions of this Agreement.

d. <u>Notice</u>. Any notice required by the provisions of this Agreement shall be mailed to, served upon, or e-mailed to the following persons at the following addresses:

e. <u>Entire Agreement</u>. This Agreement, together with Exhibit "A", represents the entire Agreement between the Village and the City and supersedes all prior negotiations, representations or agreements, either written or oral.

ORDINANCE NO.

AN ORDINANCE AUTHORIZING THE DISPOSAL OF SURPLUS PERSONAL PROPERTY OWNED BY THE CITY OF LOVES PARK, ILLINOIS

WHEREAS, pursuant to 65 ILCS 5/1-2-1, the City of Loves Park, an Illinois municipal corporation ("City"), is authorized and empowered to adopt and enforce the provisions of this ordinance; and

WHEREAS, the City desires to dispose of certain personal property that the City believes is no longer necessary or useful to, or for the best interests of the City; and

WHEREAS, pursuant to 65 ILCS 5/11-76-4 the simple majority of the corporate authorities of the City currently holding office have determined that the personal property as identified in Exhibit A attached hereto and made a part hereof is no longer of use or value to the City, and that the best interest of the City would be served by disposal of the same.

<u>NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY</u> <u>COUNCIL OF THE CITY OF LOVES PARK. COUNTY OF WINNEBAGO AND COUNTY</u> <u>OF BOONE. ILLINOIS, AS FOLLOWS:</u>

- 1. The above recitals are incorporated herein and made a part hereof.
- 2. The Loves Park Fire Chief or his designee is directed to take such actions as may be necessary to sell the 2009 International 4000 Series 4300 Ambulance acquired from the City of Westmont in September 2019 using Foreign Fire Insurance funds. Proceeds from the sale will be returned to the Foreign Fire Insurance checking account.
- 3. The Loves Park Fire Chief or his designee is directed to take such actions as may be necessary to sell the backup Zoll Defibrillator acquired by the City in May 2019. This equipment was purchased with donated funds and the proceeds will be returned to the general fund.
- 4. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any court or competent jurisdiction, such

portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining provisions thereof.

- 5. All other provisions of the Code and any City Ordinances or Resolutions shall remain in effect as previously enacted except those Ordinances, Resolutions or parts thereof in conflict with the provisions of this Ordinance that are hereby repealed.
- 6. This ordinance shall become effective upon its passage, approval and publication as provided by law.
