ORDINANCE NO.

AN ORDINANCE AMENDING CHAPTER 6, SECTION 6-43 OF THE CODE OF ORDINANCES OF THE CITY OF LOVES PARK, ILLINOIS.

WHEREAS, Chapter 6, Section 6-43 of the Code of Ordinances for the City of Loves Park identifies the types of classes of liquor licenses; and

WHEREAS, Chapter 6, Section 6-43 (a)(1) of the Code of Ordinances of the City of Loves Park identifies the *Class A license*; and

WHEREAS, the City of Loves Park desires to amend Chapter 6, Section 6-43 (a)(1); and

WHEREAS, Chapter 6, Section 6-43 (a)(5) a. of the Code of Ordinances of the City of Loves Park identifies the *Class R-1 license*; and

WHEREAS, the City of Loves Park desires to amend Chapter 6, Section 6-43 (a)(5) a.; and

WHEREAS, Chapter 6, Section 6-43 (a)(5) b. of the Code of Ordinances of the City of Loves Park identifies the *Class R-2 license*; and

WHEREAS, the City of Loves Park desires to amend Chapter 6, Section 6-43 (a)(5) b.; and

WHEREAS, Chapter 6, Section 6-43 (a)(10) of the Code of Ordinances of the City of Loves Park identifies the *Class F license*; and

WHEREAS, the City of Loves Park desires to amend Chapter 6, Section 6-43 (a)(10).

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVES PARK, WINNEBAGO COUNTY, ILLINOIS AS FOLLOWS:

1) Chapter 6, Section 6-43 (a)(1) of the Code of Ordinances of the City of Loves Park is hereby amended as follows:

Class A licenses. Class A licenses shall authorize the retail sale on the premises specified of alcoholic liquor for consumption on the premises as well as other packaged retail sale of such liquor, providing, however, that the other packaged retail sales of such liquor shall not exceed twenty percent of the total sales of alcoholic beverages. The annual license fee for

the year commencing May 1 of each year for such license shall be \$2,000.00. The issuance of class A licenses shall be subject to the following limitations:

- a. There may not be more than fifteen class A licenses issued and outstanding within the city at any given time.
- b. No new class A license shall be granted if the location of the license is within 500 feet of an existing class A license. The distance between class A licenses shall be measured from the main entrances of each business. This prohibition will not apply to any existing class A licenses or the granting of new class A licenses to locations where class A licenses have already been granted.
- c. No new class A license shall be granted if the location of the license is within 500 feet of an existing class F License. The distance between any class A license and any class F license shall be measured from the main entrances of each business. This prohibition will not apply to any existing class A licenses or the granting of new class A licenses to locations where class A licenses have already been granted.
- 2) Chapter 6, Section 6-43 (a)(5) a. and b. of the Code of Ordinances of the City of Loves Park is hereby amended as follows:

Class R licenses. Class R licenses shall authorize retail sales as follows:

- a. Class R-1 licenses shall authorize the retail sale on the premises specified of alcoholic liquor for consumption on the premises by restaurants and subject to the requirement that at least 55 percent of the premises' gross receipts be from the sale of food. Further, the class R-1 license shall provide for the retail sale of packaged alcoholic liquor providing that said retail sales of such liquor shall not exceed twenty percent of the total sales of all alcoholic beverages. The annual license fee for the year commencing May 1 of each year for such R-1 license shall be \$2,000.00.
- b. Class R-2 licenses shall authorize the retail sale on the premises specified of alcoholic liquor for consumption on the premises by bowling alleys, and other recreational facilities, and the requirement that at least 55 percent of the premises' gross receipts be from the operation of the bowling alleys and other recreational facilities, and that bowling and other recreational facilities are offered in the same manner as during the rest of the week with all of the normal facilities being open. The annual license fee for the year commencing May 1 of each year for such R-2 license shall be \$2,000.00. Further, the class R-2 license shall provide for the retail sale of packaged alcoholic liquor providing that said retail sales of such liquor shall not exceed twenty percent of the total sales of all alcoholic beverages.
- 3) Chapter 6, Section 6-43 (a)(10) of the Code of Ordinances of the City of Loves Park is hereby amended as follows:

Class F licenses. Class F licenses shall authorize the retail sale and consumption of alcoholic liquor within the building located on the premises, provided the licensed premises also has, locates, maintains and lawfully operates video gaming terminals (as defined under the Illinois Video Gaming Act, 230 ILCS 40/1 et seq. within the class F licensed

establishment. The annual license fee for the year commencing May 1 of each year for such license shall be \$2,000.00. The issuance of class F licenses shall be subject to the following limitations:

- a. The holder of a class F license may not exceed the time and hour limits as established in section 6-2.
- b. The \$2,000.00 licensing fee may be refunded only if the gaming license is denied, less the retention of a \$200.00 administrative fee, otherwise, this fee shall not be refundable nor prorated.
- c. Live music, DJ, karaoke, and/or juke boxes are prohibited on the licensed premises. Notwithstanding the foregoing, a music system, operated solely by the licensee, shall be permitted so long as such system is operated at such levels so as to not be heard outside the licensed building.
- d. Licensees shall not be permitted to have a patio or beer garden of any kind.
- e. If the area so licensed is within another existing business space, then said area must be segregated from the remainder of the building and must have a separate outside entrance. The retail sale and consumption of alcoholic liquor may only take place within said licensed segregated space.
- f. There may not be more than 25 class F licenses issued and outstanding within the City at any given time.
- g. No person, entity or establishment shall be eligible to hold a class F license if any of its owners have an ownership interest, whether direct or indirect, in any two other establishments holding a class F license within the city. Violation of this section shall be grounds for revocation of all such liquor licenses.
- h. No new class F license shall be granted if the location of the license is within 500 feet of an existing class F license. The distance between class F licenses shall be measured from the main entrances of each business. This requirement will not apply to any existing class F licenses or the granting of new class F licenses at locations where class F licenses have already been granted. However, if an existing class F license ceases or lapses for more than six consecutive months, and doesn't meet the spacing requirements of this section, then a new class F license may not be established at that location.
- i. No new class F license shall be granted if the location of the license is within 500 feet of an existing class A license. The distance between class F license and any class A license shall be measured from the main entrances of each business. This requirement will not apply to any existing class F licenses or the granting of new class F licenses at locations where class F licenses have already been granted. However, if an existing class F license ceases or lapses for more than six consecutive months, and doesn't meet the spacing requirements of this section, then a new class F license may not be established at that location.

AN ORDINANCE APPROVING THE ISSUANCE OF A CLASS "B" LIQUOR LICENSE LOCATED AT 7650 NORTH ALPINE ROAD PURSUANT TO CHAPTER 6, SECTION 6-37 OF THE CODE OF ORDINANCES OF THE CITY OF LOVES PARK, ILLINOIS

WHEREAS, Chapter 6, Sections 6-37 and 6-43 of the Loves Park Code of Ordinances ("Code") of the City of Loves Park ("City") regulate the number and classes of liquor licenses, respectively, existing within the City; and

WHEREAS, a Class "B" liquor license authorizes the retail sale of packaged alcoholic liquor but not for consumption on the premises; and

WHEREAS, the City now desires to approve the change in liquor license class from a Class "E" to a Class "B" liquor license to Pala Fuels, Inc. ("Licensee"), pursuant to Chapter 6, Section 6-37 of the Code; and

WHEREAS, said liquor license shall be issued for use only within that part of the building located at 7650 North Alpine Road, Loves Park, Illinois, 61111; and

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOVES PARK, WINNEBAGO COUNTY, ILLINOIS, AS FOLLOWS:

- 1. The above recitals are incorporated by reference herein and made a part hereof.
- 2. The issuance of a Class "B" liquor license to the Licensee for use at the Premises is hereby approved pursuant to Chapter 6, Section 6-37 of the Code.
- 3. Final issuance of the liquor license by the local liquor commissioner will be subject to review and approval of the liquor license application by the local liquor commissioner along with compliance by Licensee with all Ordinances of the City of Loves Park and all applicable State and/or Federal laws.
- 4. All other provisions of the Code and any City Ordinances or Resolutions shall remain in effect as previously enacted except that those Ordinances, Resolutions or parts thereof in conflict with the provisions of this Ordinance are hereby repealed.
- 5. This Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.
